1. RULES

- 1.1 The organising authority of the regatta is Port River Sailing Club.
- 1.2 The regatta will be governed by the rules as defined in The Racing Rules of Sailing .
- 1.3 The class rules of the International Fireball Class shall apply, with the following exceptions.

2. ADVERTISING

- 2.1 Advertising will be as defined by ISAF regulation 20.
- 2.2 Boats may be required to display advertising chosen and supplied by the organizing authority.
- 2.3 The organising authority reserves the right to refuse advertising by a boat or competitor when it is in conflict with an event sponsor or the laws of the South Australian or Australian Governments.

3. ELIGIBILITY AND ENTRY

- 3.1 The regatta is open to all boats of the International Fireball class.
- 3.2 Competitors must be current members of their National Authority.
- 3.3 Eligible boats may enter by completing the attached form and sending it, together with the required fee, to the IFASA Treasurer by 1700 hours on Friday 24th October 2014.
- 3.4 Late entries will be accepted up until 1000 hours on Sunday 26th October with payment of the late entry fee refer Fees.

4. FEES

4.1 Required fees are in \$AUS as follows: Entry Fee = \$20.00

5. SCHEDULE OF EVENTS

5.1 Regatta Program

- 5.2 Multiple races are scheduled.
- 5.3 No warning signal shall be made after 1630 hours on the day of the event.

6. MEASUREMENTS

- 6.1 Each boat shall produce a valid measurement certificate.
- 6.2 In addition the regatta measurer who shall be the elected measurer for the International Fireball Association of South Australia may perform spot checks of any measurement.

7. SAILING INSTRUCTIONS

7.1 The sailing instructions will be available after 0900 hours on the 26th October 2014 at the registration area.

8. VENUE

- 8.1 The regatta venue shall be in the Port River in the waters between the Birkenhead bridge and the Diver Derrick bridge.
- 8.2 Access to this area is available via the beach immediately next to the Birkenhead Tavern, 3 Elder Road, Birkenhead.

9. THE COURSES

- 9.1 The courses to be sailed will be Windward-Leeward format.
- 9.2 Course diagrams, including the order in which marks are to be passed, and the side on which each mark is to be left will be provided in the sailing Instructions.
- 9.3 The approximate race duration will be 15 minutes.

10. PENALTY SYSTEM

10.1 Rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

11. SCORING

- 11.1 The Low Point System of Appendix A will apply.
- 11.2 One (1) race is required to be completed to constitute a series.
 - (a) When fewer than Four (4) races have been completed, a boat's series score will be the total of her race scores.
 - (b) When Five (5) or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

12. SAFETY

- 12.1 All competitors shall wear personal flotation devices which are in good condition and are in accordance with the specifications issued or approved by a national authority or standards organisation and branded in the country of origin or manufacture.
- 12.2 Attention is drawn to Rule 1.2 and Rule 4
- 12.3 Discretionary penalties will apply to Rule 41 Outside Help. Actions of the Race Committee in retrieving crews from the water and returning them to their boats may not be penalised.

13. SUPPORT BOATS

- 13.1 Team managers, coaches and other support personnel shall register by completing a registration form available at registration. Approved Support Boats shall keep at least 100m clear of the course area during racing, except when asked to assist by the race committee.
- 13.2 All support and coach boats will display a plain white identification flag of minimum size 400mm x 600mm.

14. RIGHTS TO USE NAME AND LIKENESS

14.1 In participating in an event, a competitor automatically grants to the organising authority and the sponsors of the event, the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of him/her during the period of the competition for the said event in which the competitor participates and in all material related to the said event without compensation.

15. RADIO COMMUNICATION

15.1 While on the water, a boat shall not carry equipment capable of making radio transmissions or receiving radio transmissions except for equipment provided by the organising authority. This restriction also applies to mobile telephones.

16. PRIZES

16.1 Prizes will be given as follows:

First Overall \$100 Second Overall \$50 First Handicap \$100

16.2 Other prizes may be awarder by the Organising Authority.

17. DISCLAIMER OF LIABILITY

- 17.1 Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race.
- 17.2 The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with, or prior to, during, or after the regatta.

18. INSURANCE

18.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$5M Aus (\$10M recommended) or the equivalent. All owners/competitors who sign the Entry Form are deemed to have made a declarationthat they hold such cover.
